The maintenance guide serves as a basis for a contract between the artist and the new owner. This contract will ensure the future life of the artwork as it contains a description of what to do when repairs or changes are needed, as well as an over-view of all the materials and paints used.

Examples of ways of sharing experience, insights and

- Networking and Mentorship. Networking in local or online groups, with fellow commissioners and artists can help learn from other experiences, gain new ideas, and foster collaboration on future sustainable art projects.
- Exhibitions and Festivals. By showcasing work in shows and festivals that celebrate eco-friendly art and sustainable practices, you raise awareness and demonstrate the potential of sustainable materials and techniques in art.
- Education and Outreach. Share the knowledge of your experience with sustainable art practices at schools and organizations. The next generation of artists will be inspired to adopt an environmentally conscious approach to their work
- · Data and stories. While data collection provides the means to analyse carbon emissions, the responses provide the stories behind the facts and figures. It is examples like these that inspire and motivate others to take action!

By adding the artwork to art databases of the city or municipality, the cultural ministry, heritage organizations, art institutions and to databases dedicated to citizen engaged art, it will become the subject of research by writers and scientists.

Their publications and academic contributions will discuss the work within examples of citizen engagement art and of the commitment to ecological and sustainable change.
